The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in roadworks, for the DRAIN CLEARING AND VERGE MAINTENANCE ON P496 IN THE EMPANGENI REGION. This project is in the province of KwaZulu-Natal in the district municipality of King Cetshwayo and local municipality of Umhlathuze. The duration of the project is 12 months.

Only tenderers that satisfy the eligibility criteria stipulated in clause C.2.1 of the Tender Data are eligible to have their tenders considered.
