The Province of KwaZulu-Natal, Department of Transport, invites tenders from contractors, experienced in roadworks, for the DRAIN CLEARING AND VERGE MAINTENANCE ON P393 IN THE EMPANGENI AREA OFFICE. This project is in the province of KwaZulu-Natal in the district municipality of King Cetshwayo and local municipality of Umhlathuze. The duration of the project is 12 months.

Only tenderers that satisfy the eligibility criteria stipulated in clause C.2.1 of the Tender Data are eligible to have their tenders considered.

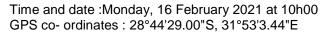

INTRODUCTION

(c)

The National Industrial Participation (NIP) Programme, which is applicable to all government procurement contracts that have an imported content, became effective on the 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIP requirements. NIP is obligatory and therefore must be complied with. The Industrial Participation Secretariat (IPS) of the Department of Trade and Industry (DTI) is charged with the responsibility of administering the programme.

1 PILLARS OF THE PROGRAMME

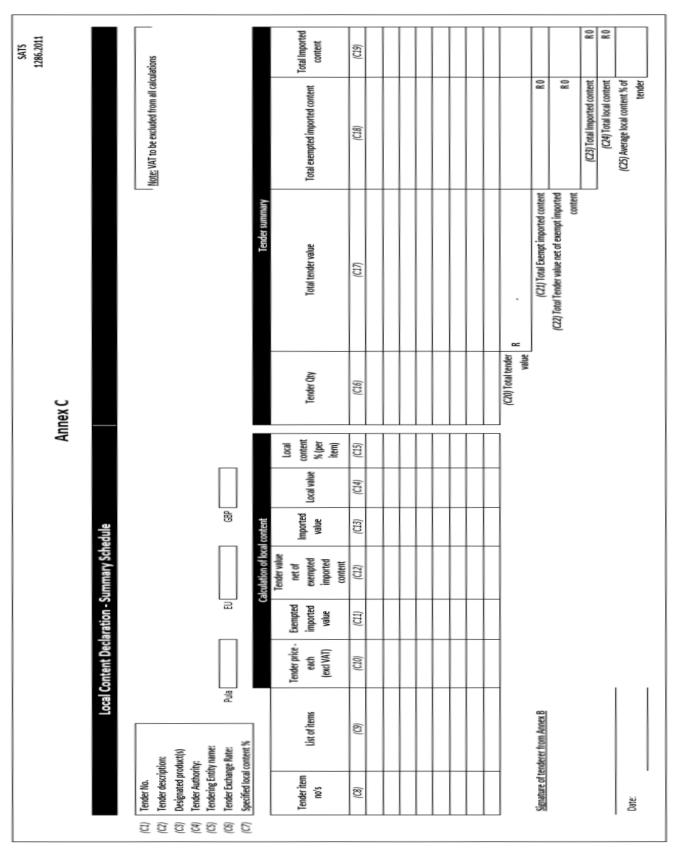
