Contracts and Contractor OHS management, 32-726 (Rev. 3)

Sustainability Systems (OHS) is pleased to announce the release of the revised 32-726 (rev. 3) Contracts and Contractor OHS management standard. This Standard was previously called SHE Requirements for the Commercial Process. The review of the standard resulted in the amalgamation of 32-726 with the Manual for Developing SHE Specifications (32-524). Emanating out of the review and amalgamation, the standard was re-named as Contract and Contractor OHS Management (32-726), which was approved and published accordingly.

The review of the standard was prompted by a request which emanated from the business to review the document to improve the contractor management processes and align with relevant amended legislation and Eskom procedures.

The standard outlines the key responsibilities of key role players and underlines the minimum OHS requirements that shall be addressed during the contractor OHS management phases to ensure standardised and consistent OHS contractor management in Eskom.

The document is effective from date of authorisation.
