1. BACKGROUND

Rhinoceros dehorning is one of the measures taken to reduce the risk of rhinoceros poaching and to safeguard the animals from being killed. Rietvlei Nature Reserve accommodates a rhinoceros family group and rhinoceros poaching incidents have taken place in the past. As a result of the incidents, rhinoceros dehorning has been implemented at the Nature Reserve since 2010.

Initially, the dehorned rhinoceros' horn was stored at safe facilities at the BKS building (finance offices). However, the building was vacated to move of Tshwane staff and equipment to Tshwane House. At that point in time, alternative safe storage facilities were not available and had to be outsourced to a safe facility and company that complies with legislative requirements.

2. PROJECT SCOPE

The Rhino horn belonging to the City of Tshwane (CoT) to be collected, transported and kept in a safe and secure storage facility that complies with all legal requirement as stipulated in the National Environmental Management: Biodiversity act; 2004 (Act no 10 of 2004) Norms and Standards for the marking of rhinoceros and rhinoceros' horn and Threatened or protected species regulations, 2007. Government Notice R152 in Government Gazette 29657, dated 23 February 2007. Commencement date: 1 June 2007 [GN R150, Gazette No. 29657]

Rhino horn to be kept safe that is compliant to SANS 953-1 and 953-2 to prevent or minimize the risk of theft of horns
A Threatened Or Protected Species (TOPS) permit is required as prescribed for the safekeeping and transport of Rhino horn

CoT will apply for the Threatened Or Protected Species (TOPS) permit as prescribed by the National Environmental Management: Biodiversity Act 2004 (No.10 of 2004) for the transport and safekeeping of the rhino horns at the secured facility for the duration of the time.

3. DELIVERABLES

The vendor is required to collect, transport and store the existing rhino horn in a safe and secure facility.

Horns should be stored within an immovable safe, compliant to SANS 953-1 and 953-2.

24-hour presence of armed security personnel. (Minimum requirement grade c) is required.

Horns should be stored off the floor or ground, in an organised display, for example in a matrix of six to enable rapid detection of tampered or missing horns according to the Rhino horn stockpile management, minimum standards and best practises from East and Southern Africa

A register/ logbook for recording all persons entering should be maintained.

The safe containers to be inspected at any time by the legal owners (CoT official) for confirmation of the storage of the rhino horns as well as randomly inspections by Gauteng Department of Agriculture and Rural Development (GDARD) and/or Department of Environmental Affairs (DEA)

The City of Tshwane will apply for the necessary TOPS permit, on behalf of the successful bidder, when approval is received from DEA, an official purchase order will be issue as indication that the bidder can do the necessary arrangements with the responsible official form City of Tshwane to proceed with the services to transport and safe keeping of the rhino horns.

One service provider will be appointed for the quotation.

4. STAGES OF EVALUATION

This bid will be evaluated in the following four stages:

- Stage 1: Administrative compliance
- Stage 2: Mandatory requirements
- Stage 3: Functionality criteria
- Stage 4: Preference point system

4.1 STAGE 1: ADMINISTRATIVE COMPLIANCE

All the bids will be evaluated against the Administrative responsiveness requirements as set out in the list of returnable documents.

4.2 STAGE 2: MANDATORY REQUIREMENTS

- Certified copy of the (PSIRA) Private Security Regulatory Authority certificate (submit certificate for the company)

- Qualifications of the four (4) grades and personnel of which grade C registration certificate is mandatory.
- Bidders needs to quote on the transportation costs, if not quoted on the transport cost the bidder will be disqualified.

4.3 STAGE 3: FUNCTIONALITY CRITERIA

The criteria below detail what components will be evaluated on and how the ratings (points) will be allocated. Only responsive bids will be considered, meanwhile compliance to tendering rules and submission of returnable documents is still mandatory. Further evaluation will be only for bidders who scored 70 points and above.

4.4 STAGE 4: PREFERENCE POINT SYSTEM

The 80/20 preference point system, in terms of the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000) Regulations 2017, will be applicable.

- 80 points for price
- 20 points for B-BBEE status (the service provider must submit a certified copy of the B-BBEE level rating certificate)

5. PRICING SCHEDULE

For evaluation purposes the following pricing schedule will be used:

- Monthly rate for the storage of rhino horn per kilogram (1kg) will be used to calculate the price not the total tender amount.
- A price for the operational team to collect and transport rhino horn per hour.

6. VALIDITY PERIOD

The validity period for the tender after closure is 90 days.

7. MARKET ANALYSIS

The City of Tshwane reserves the right to conduct a market analysis. Should the City exercise this option, where a tenderer offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will

be made with the tenderer if they will be able to deliver on the price. If a service provider confirms that they cannot, the service provider will be disqualified based on being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier to deliver will be handled in terms of the contract, including performance warnings, and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market-related price with a tenderer scoring the highest points. If the service provider does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the service provider scoring the second-highest points. If the service provider scoring the second-highest points does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the tenderer scoring the third-highest points. If a market-related price is not agreed upon, the City reserves the right to cancel the quotation.

- (j) **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- (k) **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- (l) **“non-firm prices”** means all prices other than “firm” prices;
- (m) **“person”** includes a juristic person;
- (n) **“QSE”** means a Qualifying Small Enterprise as defines by Codes of Good Practice issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (o) **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- (p) **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- (q) **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- (r) **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- (s) **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.

3. ADJUDICATION USING A POINT SYSTEM

- 3.1 The bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 Preference points shall be calculated after prices have been brought to a comparative basis taking into account all factors of non-firm prices and all unconditional discounts;.
- 3.3 Points scored must be rounded off to the nearest 2 decimal places.
- 3.4 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 3.5 However, when functionality is part of the evaluation process and two or more bids have scored equal points including equal preference points for B-BBEE, the successful bid must be the one scoring the highest score for functionality.
- 3.6 Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

4. POINTS AWARDED FOR PRICE

4.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

80/20

P_s = Points scored for comparative price of bid under consideration

- 5.2 A bidder who qualifies as an EME in terms of the B-BBEE Act must submit a sworn affidavit confirming Annual Total Revenue and Level of Black Ownership.
- 5.3 A Bidder other than EME or QSE must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating

issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.

- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary Institutions and Public Entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
- 5.8 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.
