Formal tender sealed and clearly marked "RE-ADVERTISED TD-05/04/2022: APPOINTMENT OF A PANEL OF HARDWARE SUPPLIERS FOR OUDTSHOORN MUNICIPALITY FOR A PERIOD OF 36 MONTHS" must be placed in the Municipal tender box, **26 Church Street, OUDTSHOORN** no later than **12:00 on Friday, 08 July 2022** and will be opened in public immediately thereafter in the **Supply Chain Management Office, 26 Church Street, OUDTSHOORN** or any alternative place in Oudtshoorn Municipal Offices.

A compulsory briefing session will be held at 10:00 on Tuesday, 28 June 2022 at the Civic Centre, New Council Chamber 69 Voortrekker Road, Oudtshoorn. No grace period will be allowed.

- The following COVID-19 protocol will be applicable at the briefing session:
 - Only 1 representative per tendering party
 - Pre-screening: Measuring temperature and capturing of information
 - Sanitize: Sanitizing hands before entering
 - Facial masks: All attendees to wear masks; no mask, no entry
 - Social distancing: Keep at least 1.5m apart from other attendees

A set of fully completed tender documents must be submitted on the original documents and remain valid for a maximum of 120 days after the closing date of the tender. A set of tender documents can be obtained at a non-refundable cost of **R318-00 including VAT incl / or the PDF Document free of charge per email request to Ms J. Rollison**. Then hard copies will be physically handed only to prospective bidders who produce a receipt for the payment of the tender document at the SCM Offices.

The municipality reserves the right to withdraw any invitation to tender and/or re-advertise or reject any formal tender or to accept a part of it. The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this tender may not materialize.

Note that Local Content and Production will form part of evaluation and therefore all potential bidders who fail to meet the minimum threshold for local content will not be considered for award.

Formal Tenders TD-05/04/2022 will be evaluated and adjudicated in terms of the **80/20** Preference Point System prescribed by the Oudtshoorn Municipality's Supply Chain Management Policy.
